

The franchises described in this disclosure document are for the operation of a warehouse distribution Outlet(s) using the name 1-800-RADIATOR & A/C™, which will sell radiators, condensers, air conditioning compressors, fan assemblies, and other automotive parts to automobile repair shops, fleets, chain accounts and retail consumers. Additional automotive parts are currently being developed and tested and may be added to the System. They include fuel pumps, exterior body parts, starters and alternators.

The total investment necessary to begin operation of a 1-800 Radiator & A/C™ start-up Outlet is \$322,500 to \$768,000. This includes \$232,000 to \$482,000 that must be paid to the franchisor or affiliate. The total investment necessary to begin operation of a 1-800 Radiator & AC™ resale Outlet is \$268,500 to \$2,254,000. This includes \$210,000 to \$2,060,000 that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make a payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.


