

The franchise offered is for the operation of a distribution warehouse(s) using the name "1-800-RADIATOR & A/C®" and other trademarks, which sell(s) radiators, condensers, air conditioning compressors, fan assemblies, fuel pumps, hoses, exhaust-related products and services, heavy duty hard parts and services and other automotive parts and related services to automobile repair shops and parts stores, fleets, chain accounts and retail consumers.

The total investment necessary to begin operation of a 1-800-RADIATOR & A/C® Start-up Warehouse franchise is \$395,500 to \$1,109,000. This includes \$305,000 to \$805,000 that must be paid to the franchisor or affiliate. The total investment necessary to begin operation of a 1-800-RADIATOR & A/C® Re-sale Warehouse franchise is \$283,500 to \$5,269,000. This includes \$225,000 to \$5,075,000 that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

- 1. THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY MEDIATION AND/OR ARBITRATION ONLY IN SOLANO COUNTY, CALIFORNIA. OUT-OF-STATE LITIGATION, MEDIATION AND/OR ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO MEDIATE AND/OR ARBITRATE WITH US IN SOLANO COUNTY, CALIFORNIA THAN IN YOUR OWN STATE.
- 2. YOU MUST COMPLY WITH MINIMUM AND/OR MAXIMUM PRICES SET BY THE FRANCHISOR FOR THE GOODS AND SERVICES YOU SELL. THIS REQUIREMENT MAY REDUCE YOUR ANTICIPATED REVENUE.
- 3. YOU MUST MAKE A SPECIFIC LEVEL OF INVENTORY PURCHASES, EVEN IF YOU DO NOT NEED THAT MUCH. THE FRANCHISOR MAY TERMINATE YOUR FRANCHISE IF YOU DON'T.
- 4. THE GUARANTOR'S FINANCIAL CONDITION, AS REFLECTED IN ITS FINANCIAL STATEMENTS (SEE ITEM 21), CALLS INTO QUESTION THE GUARANTOR'S FINANCIAL ABILITY TO PROVIDE SERVICES AND SUPPORT TO YOU.
- 5. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We use the services of one or more FRANCHISE BROKERS or referral sources to assist us in selling our franchise. A franchise broker or referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
