The franchised business you will own and operate is a restaurant offering and selling various sizes and recipes of pizza for eat-in, carryout and delivery, and soft drinks under our designated marks.

The total investment necessary to begin operation of a Restaurant ranges from \$218,150 to \$764,250. This includes \$29,500 that must be paid to the franchisor or affiliate.

The total investment necessary to begin operation under a Development Agreement ranges from \$738,650 to \$1,284,750 (for a Development Agreement requiring the development and operation of 10 Restaurants). This includes \$550,000 that must be paid to the franchisor or affiliate.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully.
