As a 2nd Shift Franchising, LLC (“2nd Shift”) franchisee, you will own and operate a business that provides 24/7 plumbing and sewer services with no emergency service fees. The services you will provide include but are not limited to: sewer hookups; sewer line inspections; sewer line repairs; sewer cleaning and jetting; general plumbing services; underground repairs; excavation; unclogging drains; bathroom remodels; and drain repairs. Your primary responsibility as a franchisee will be to manage the day-to-day operations, offer quality customer service, coordinate, set-up and manage the sales, and provide the services.

The total initial investment necessary to begin operation of a 2<sup>nd</sup> Shift franchise is \$57,100 to \$123,000. This includes \$30,000.00 Initial Franchise Fee which must be paid to the Franchisor.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least fourteen (14) calendar days before you can sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

1. THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US ONLY IN INDIANA. THE FRANCHISE AGREEMENT REQUIRES ANY CLAIMS, CONTROVERSIES OR DISPUTES TO BE SUBMITTED TO ARBITRATION ONLY IN INDIANA. OUT-OF-STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES AND IT MAY COST YOU MORE TO ARBITRATE IN INDIANA THAN IN YOUR OWN STATE. ADDITIONALLY, ANY CLAIMS, CONTROVERSIES OR DISPUTES NOT RESOLVED THROUGH ARBITRATION MUST BE BROUGHT IN THE FEDERAL DISTRICT COURT WHOSE JURISDICTION ENCOMPASSES HOWARD COUNTY, INDIANA, OR IN ANY COURT OF GENERAL JURISDICTION IN HOWARD COUNTY, INDIANA.
2. THE FRANCHISE AGREEMENT STATES THAT INDIANA LAW GOVERNS THE AGREEMENT AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
3. WE, IN OUR SOLE DISCRETION, MAY REQUIRE YOUR SPOUSE AND/OR PARENTS TO GUARANTEE ALL OF YOUR OBLIGATIONS UNDER THE FRANCHISE AGREEMENT, EVEN IF THEY ARE NOT INVOLVED IN FRANCHISE OPERATIONS. IF REQUIRED, THEIR PERSONAL ASSETS WOULD BE AT RISK.
4. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
