The franchise offered is a retail business that provides discounted tobacco and accessories to customers.

The total investment necessary to begin operations of a 3 Monkeys Smoke Shop is \$156,250 to \$202,700. This does include the \$25,000 franchise fee that must be paid to the franchisor or affiliate.
