The franchise offered is for the operation of a 30 MINUTE HIT® Gym using our Marks, Copyrights and our System featuring a high-intensity circuit training fitness program known as "30 MINUTE HIT" as well as other products and services we designate or approve.

The total initial investment necessary to begin operation of a 30 MINUTE HIT® Gym unit franchise ranges from \$56,575 to \$125,500. This includes \$35,000 that must be paid to the franchisor and affiliates.

The total initial investment necessary to begin an Area Development Business of 3 to 10 30 MINUTE HIT® Gyms ranges from \$71,575 to \$150,500 for the Area Development Program, including the cost of one 30 MINUTE HIT® Gym. This includes \$50,000 to \$85,000 (based on 3 to 10 Unit Franchises) that must be paid to the Franchisor or affiliate (the Development Fee of \$5,000 per Gym plus the amounts you pay to the Franchisor or an affiliate for your first 30 MINUTE HIT® Gym).

This Disclosure Document summarizes certain provisions of your Franchise Agreement (and/or Area Development Agreement) and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payments to the franchisor or an affiliate in connection with the proposed franchise sale. Note, however that no government agency has verified the information contained in this document.
