911 Franchising Corporation offers franchises for the operation of a commercial driving school that offers driver education taught by certified EMS/EMTs, trained firefighters, active duty and formerly commissioned police officers, officers with arresting authority (i.e., jailers, prison guards with arresting authority) or others who meet our qualifications. The total investment necessary to begin operation of a 911 Driving School franchise ranges from \$103,800 to \$184,000. This includes an amount ranging from \$39,500 to \$57,500 that must be paid to us.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

OUT-OF-STATE MEDIATION, ARBITRATION OR LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST MORE TO MEDIATE, ARBITRATE OR LITIGATE WITH US IN WASHINGTON THAN IN YOUR HOME STATE.
