The Franchise offered is for the operation of a boxing and kick boxing center that provides a customized physical fitness training program, which includes a proprietary system of challenging work out stations. The franchise will offer memberships for professional assistance that will coach clients towards a healthy lifestyle complimented with motivational support and a step-by-step boxing or kick boxing fitness program that incorporates functional, interval and cardiovascular regimens without having to use exercise machines. The franchise is a specialized fitness center, dedicated to serving clients who seek assistance for a better and healthier lifestyle in one simple package, under the name “9Round™.” The Initial Franchise Fee is \$20,000 for exclusive rights to operate a boxing and kick boxing fitness center in a specific area defined by us. Additional Franchises will be available for a reduced fee of \$15,000 per Franchise. The total estimated initial investment required for a 9Round™ Franchise ranges from \$67,800 to \$116,600 depending on a number of factors that are more fully discussed in Item 7. This includes the Initial Franchise Fee of \$20,000 (as discussed in Item5) that must be paid to the franchisor or affiliate.

- 2) THE FRANCHISE AGREEMENT AND DEVELOPMENT AGREEMENT STATES THAT SOUTH CAROLINA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LAWS IN YOUR STATE.
