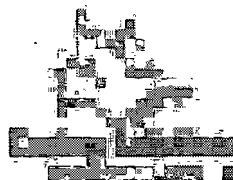

You will operate an agency that markets and provides supplemental non-medical and companion care to clients within their homes and to clients who are in assisted living or nursing facilities, operating under the A Better Solution in Home Care Brand (or in the state of Florida, the "Caring Solutions in Home Care" Brand) and using the A Better Solution in Home Care System Program.

The total estimated required initial investment to begin operation of A Better Solution, Inc. a franchised business ranges from \$70,740 to \$137,490. This includes \$42,750 which must be paid to the franchisor or an affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this document and all accompanying agreements carefully.
