The franchise offered is for the right to operate an A Buyer's Choice Home Inspections® residential and commercial real property inspection business in a specific geographic territory.

The total investment necessary to begin operation of an A Buyer's Choice Home Inspections® business ranges from \$36,665 to \$42,715. This amount includes \$29,900 that must be paid to the franchisor. If you want development rights, you generally must pay us a development fee equal to \$14,950 (the initial franchise fee for the first ABCHI Franchised Business) plus a deposit of \$14,950 for each additional ABCHI Franchised Business.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.
