The franchisee will operate one or more retail frozen custard (and related products) stands where the public may purchase frozen custard, frozen yogurt, sherbet, soft drinks, and other desserts and related food products as approved by us the franchisor. Our services and products are used primarily by the motoring public for desserts or refreshment stops.

The total investment necessary to begin operation of an Abbott's Frozen Custard franchise is between \$180 300 and \$272,000, exclusive of real property or any salary for the owner during the initial startup period. This includes the \$35,000 initial franchise fee that must be paid to us. If you choose to enter into a Development Agreement, the total investment necessary will be between \$546,900 and \$822,000 to open three (3) stores, exclusive of real property or any salary for the owner during the initial startup period. This includes a development tee of \$21,000 and initial franchise fees of \$90,000 that must be paid to us.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English Read this disclosure document and all accompanying agreements carefully You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the tranchisor or an affiliate in connection with the proposed franchise sale **Note, however, that no governmental agency has verified the information contained in this document**
