The Franchise offered is for the sale, manufacture and installation of seamless siding, seamless gutters, soffit, fascia and accessories using the Franchisor's name and marks. If you sign the appropriate Addenda, you may also sell windows and/or metal roofing identified by Franchisor's marks.

The total investment necessary to begin operation of an abc Seamless[®] business is estimated to be between \$86,000 and \$268,500. This includes between \$57,000 and \$90,380 that must be paid to the franchisor or an affiliate.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
