Above Grade Level, LLC offers licenses to establish and operate an Above Grade Level franchise utilizing its unique System and proprietary marks.

The total investment necessary to begin operation of an Above Grade Level franchise ranges from \$51,665 to \$76,995. This includes \$39,895 to \$54,895 that must be paid to Above Grade Level, LLC, or its affiliates.
