The total initial investment necessary to begin operations of an ABRA® Auto Body & Glass Repair Center ranges from \$263,640 to \$3,569,050, which includes an Initial Franchise Fee of \$35,000 for new franchisees and \$25,000 for existing franchisees who are opening a second or subsequent ABRA® Auto Body & Glass Repair Center.
