As an “ACASA Senior Care” Area Representative, you will solicit franchisees and multi-unit developers for our System and you must provide on-going assistance to franchisees located within your defined area. Each franchisee of an “ACASA Senior Care” franchise will license directly from us the right to operate a business providing the public with non-medical in-home personal care and assisted living/residential care placement services.

The total investment necessary to become an Area Representative is from \$101,575 to \$114,675. This includes \$95,075 that must be paid to the franchisor and/or its affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive the disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

2. THE AREA REPRESENTATIVE AGREEMENT STATES THAT CALIFORNIA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
