("we") offers the opportunity to connect your communities by operating a business providing small to medium sized residential and commercial repairs, maintenance and remodeling, including design and build projects (a "Handyman Matters Franchise") in an industry that desperately needs high level customer service, leveraging technology and fostering culture where the craftsman are treated with dignity and respect. This business operates during normal business hours using the trade name HANDYMAN MATTERS<sup>®</sup> however in the future franchisees will offer their handyman services to the public under service marks established by Ace Hardware Corporation, our ultimate parent company.

The total investment necessary to begin operation of a Handyman Matters Franchise is estimated at \$91,777 to \$136,569. This includes \$56,497 to \$62,094 that must be paid to the franchisor or an affiliate. Larger territories can be acquired in Paks of three or five franchises with the additional territories being acquired for additional, discounted fees.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make . any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

YOUR OFFICERS, DIRECTORS, PARTNERS, SHAREHOLDERS, FRANCHISE MANAGERS OR OTHER AUTHORIZED REPRESENTATIVES, AS WELL MEMBERS OF YOUR OR THEIR IMMEDIATE FAMILIES, MAY BE REQUIRED TO SIGN OUR NONDISCLOSURE AND NONCOMPETITION AGREEMENT AND AGREE TO BE BOUND BY THE CONFIDENTIALITY PROVISIONS AND COVENANTS NOT TO COMPETE EVEN IF SUCH PERSONS ARE NOT INVOLVED IN THE OPERATION OF THE FRANCHISE,
