The franchise offered is for the operation of an ACTIKARE® In-Home Care Service Franchise Business which provides affordable companion services at a client's home. An ACTIKARE® In-Home Care Service franchise offers an effective alternative to clients who prefer to receive services in their own home instead of traveling to a facility.

The estimated total investment required to begin operation of an ACTIKARE® franchised business ranges from \$31,905, to \$59,655. This includes \$20,750 to \$43,500, depending on territory size, that must be paid to the franchisor or affiliate.

This Disclosure Document summarizes provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in the document**.
