As a franchisee, you will develop and manage an ActivCore clinic, which provides out-of-network medical services to individuals through independent licensed physical therapists or chiropractors.

The total estimated investment necessary to develop and manage an ActivCore clinic within an existing host clinic ranges from \$37,200 to \$62,200. This includes \$22,500 to \$25,000 that must be paid to the franchisor or its affiliates. The total estimated investment necessary to develop and manage an ActivCore conversion clinic ranges from \$50,000 to \$103,700. This includes \$22,500 to \$25,000 that must be paid to the franchisor or its affiliates. The total estimated investment necessary to develop and manage an ActivCore full clinic ranges from \$70,500 to \$153,600. This includes \$22,500 to \$25,000 that must be paid to the franchisor or its affiliates.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
