The Franchisee will operate a store for the marketing and retail sale of lingerie, apparel, shoes, leather accessories, a selection of intimate pleasure products, DVDs, and other associated products. This Disclosure Document describes the offer of the right to establish and operate both a single Adam & Eve Store and multiple Adam & Eve Stores.

The total investment necessary to begin operation of a new Adam & Eve Store is \$170,530 to \$345,180. This includes between \$90,000 to \$133,400 that must be paid to the franchisor or affiliate. The total investment necessary to begin operation of a conversion Adam & Eve Store is \$92,530 to \$190,180. This includes between \$35,000 to \$73,400 that must be paid to the franchisor or affiliate.

We may also offer a multi-unit operator agreement to an individual or company that agrees to develop at least two Adam & Eve stores in a specific geographic area. A multi-unit operator will pay a development fee that is equal to 100% of the initial franchise fee for the first store to be developed, plus a deposit of \$10,000 for each additional store that will be developed. The total estimated investment under a multi-unit operator to develop two Adam & Eve stores is \$180,530 to \$355,180. This includes \$65,000 to \$143,400 that must be paid to the franchisor and/or its affiliate. The total investment under a Multi-Unit Operator Agreement will vary depending on the number of Stores to be developed.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

Please consider the following RISK FACTORS before you buy this franchise:

1. THE FRANCHISE AGREEMENT AND MULTI-UNIT OPERATOR AGREEMENT REQUIRE YOU TO RESOLVE DISPUTES WITH US BY ARBITRATION AND LITIGATION ONLY IN NORTH CAROLINA. OUT OF STATE ARBITRATION, MEDIATION AND LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST MORE TO ARBITRATE, MEDIATE OR LITIGATE WITH US IN NORTH CAROLINA THAN IN YOUR OWN STATE.

2. THE FRANCHISE AGREEMENT AND MULTI-UNIT OPERATOR AGREEMENT STATE THAT NORTH CAROLINA LAW GOVERNS THE AGREEMENTS, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.

3. YOUR SPOUSE MUST SIGN A DOCUMENT THAT MAKES YOUR SPOUSE LIABLE FOR YOUR FINANCIAL OBILIGATIONS UNDER THE FRANCHISE AGREEMENT, EVEN THOUGH YOUR SPOUSE HAS NO OWNERSHIP INTEREST IN THE BUSINESS. THIS GUARANTEE WILL PLACE BOTH YOUR AND YOUR SPOUSE'S MARITAL AND PERSONAL ASSETS, PERHAPS INCLUDING YOUR HOUSE, AT RISK IF YOUR FRANCHISE FAILS...

THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
