We offer qualified individuals the right to operate a business that offers and sells restoration and remediation services in residential and commercial properties under the "AdvantaClean" mark.

The total investment necessary to begin operation of an AdvantaClean business ranges from \$140,100 to \$244,950, which includes \$105,950 to \$114,950 in fees that must be paid to us or our affiliates prior to opening. We also offer qualified parties the right to enter into multiple franchise agreements at once and subsequently operate multiple AdvantaClean businesses. The total initial investment to operate two AdvantaClean businesses is \$160,600 to \$292,450, which includes \$118,950 to \$154,950 that must be paid to us or our affiliates prior to opening.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, us or an affiliate of ours in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
