You will provide drop-in childcare services at an approved location ("Center") and provide off-site childcare services at private parties and other venues ("Playcare-to-Go") within a protected area.

The total estimated initial investment for a single franchise ranges from \$326,250 – \$565,000. This amount includes the Initial Franchise Fee of \$29,500.

This Franchise Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Franchise Disclosure Document and all accompanying agreements carefully.
