The franchisee will offer business facilitation and support services to businesses in all stages, from inception to full implementation, in advertising, sales, marketing, customer service, leadership, team building, business planning, management, and organizational development, on a temporary basis.

The total investment necessary to begin operation of an AdviCoach single unit franchise is between \$66,000.00 and \$77,050.00. This includes \$55,000 that must be paid to the franchisor or affiliate.

The total investment necessary to begin operation of an AdviCoach Area Development business is between \$141,000.00 and \$277,050.00 which includes \$130,000.00 to \$255,000.00 that must be paid to the franchisor. For a 5 Unit Area Development Agreement which includes one single unit franchise agreement, the total investment is between \$141,000.00 and \$152,050.00, which includes \$130,000.00 that must be paid to the franchisor. For a 10 Unit Area Development Agreement which includes one single unit franchise agreement, the total investment is between \$216,000.00 and \$227,050.00 which includes \$205,000.00 that must be paid to the franchisor. For a 15 Unit Area Development Agreement which includes single unit franchise agreement, the total investment is between \$266,000.00 and \$277,050.00 which includes \$255,000.00 that must be paid to the franchisor.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
