This franchise is for the operation of a business that markets and sells a proprietary line of air purification, water purification, water conditioners, floor care and other products and services that create and maintain allergy friendly, clean and healthy indoor environments for homes and businesses. Our franchisees also perform testing and treatments for indoor environmental containments and perform repair and maintenance services for all of our products and certain products of our competitors. Our franchisees are required to maintain a fixed store location to operate their franchise. Our franchisees accomplish a substantial portion of their sales through in-person marketing and product demonstration.

We currently offer 4 franchise programs – our Beyond by Aerus franchise program ("<u>Beyond Program</u>"), our Standard franchise program ("<u>Standard Program</u>"), our Beyond by Aerus associate franchise program ("<u>Beyond Associate Program</u>") and our associate franchise program ("<u>Associate Program</u>").

The total investment necessary to begin operations of a franchise under the Beyond Program is \$60,600 to \$444,690. This includes up to \$320,000 that must be paid to us or our affiliate.

The total investment necessary to begin operation of a franchise under the Standard Program is \$37,500 to \$422,690. This includes up to \$300,000 that must be paid to us or our affiliate.

The total investment necessary to begin operation of a franchise under the Beyond Associate program is \$31,000 to \$109,690. This includes up to \$60,000 that must be paid to us or our affiliate.

The total investment necessary to begin operation of a franchise under the Associate Program ranges from approximately \$20,000 to \$97,690. This includes up to \$50,000 that must be paid to us or our affiliate.

We also offer to certain qualified people the right to become a Regional Developer. Regional Developers: (i) identify and screen prospective franchisees to operate under the Beyond and Beyond Associate Programs; and (ii) provide certain initial and ongoing services to new and existing franchisees under the Beyond and Beyond Associate Programs. The total investment necessary to begin operation as a Regional Developer is \$130,150 to \$1,292,580. This includes up to \$840,000 that must be paid to us or our affiliate. The total investment also includes the cost of owning a franchise under the Beyond Program.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to us or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**



The terms of your contract will govern your franchise relationship. Do not rely on the disclosure document alone to understand your contract. Read all of the contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or accountant.

OUT-OF-STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE WITH US IN TEXAS THAN IN YOUR OWN STATE.
- 2. THE FRANCHISE AGREEMENTS AND REGIONAL DEVELOPMENT AGREEMENT STATE THAT TEXAS LAW GOVERNS THE AGREEMENTS, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
