Advanced Fresh Concepts Franchise Corp. ("AFC") will grant you a franchise to use our system to offer prepared sushi and other Asian style foods from one or more (i) AFC food service counters at a grocery store, retail center or other location that someone else owns ("AFC Food Service Counter") or (ii) Wild Blue Counters at a university or other select locations ("Wild Blue Counter").

The total investment necessary to begin operation of an AFC Food Service Counter/Wild Blue Counter is as follows: (1) if you are a new franchisee, the estimated total investment for one full-time or part-time AFC Food Service Counter/Wild Blue Counter is between \$39,339 and \$136,939 for a non-AFC operated location and between \$40,339 and \$236,939 if you purchase an existing AFC operated location. This includes \$36,579 to \$215,609 that must be paid to us; (2) if you are an existing franchisee purchasing an additional full-time or part-time AFC Food Service Counter/Wild Blue Counter, the estimated total investment necessary to begin operation of each additional AFC Food Service Counter/Wild Blue Counter is between \$36,269 and \$115,874 for a non-AFC operated location and \$37,269 and \$215,874 for an existing AFC operated location. This includes \$35,119 to \$206,074 that must be paid to us; (3) if you are an existing franchisee purchasing a self-service AFC Food Service Counter/Wild Blue Counter, the estimated total investment necessary to begin operations is between \$3,350 and \$17,900. This includes \$3,250 to \$16,000 that must be paid to us.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this disclosure document can help you make your mind. What You Need To Know About Franchising Generally

<u>Continuing responsibility to pay fees</u>. You may have to pay royalties and other fees even if you are losing money.

Business model can change. The franchise agreement may allow the franchisor to change its manuals and business model without your consent. These changes may require you to make additional investments in your franchise business or may harm your franchise business.

<u>Supplier restrictions</u>. You may have to buy or lease items from the franchisor or a limited group of suppliers the franchisor designates. These items may be more expensive than similar items you could buy on your own.

Operating restrictions. The franchise agreement may prohibit you from operating a similar business during the term of the franchise. There are usually other restrictions. Some examples may include controlling your location, your access to customers, what you sell, how you market, and your hours of operation.

<u>Competition from franchisor</u>. Even if the franchise agreement grants you a territory, the franchisor may have the right to compete with you in your territory.

<u>Renewal</u>. Your franchise agreement may not permit you to renew. Even if it does, you may have to sign a new agreement with different terms and conditions in order to continue to operate your franchise business.

<u>When your franchise ends</u>. The franchise agreement may prohibit you from operating a similar business after your franchise ends even if you still have obligations to your landlord or other creditors.

Some States Require Registration

Your state may have a franchise law, or other law, that requires franchisors to register before offering or selling franchises in the state. Registration does not mean that the state recommends the franchise or has verified the information in this document. To find out if your state has a registration requirement, or to contact your state, use the agency information in Exhibit N.

Your state also may have laws that require special disclosures or amendments be made to your franchise agreement. If so, you should check the State Specific Addenda. See the Table of Contents for the location of the State Specific Addenda.
