We offer a franchise to own and operate (1) a distinctive spa concept offering facials, related beauty services, and related retail products and services under the name "Mud", and (11) a distinctive fitness studio featuring athletic conditioning on aerial silk hammocks, and related retail products and services under the name "Air"

The total investment necessary to begin operation of a Mud franchise ranges from \$88,000 to \$161,000, which does not include the cost of leasing or purchasing real estate. This includes \$44,000 that must be paid to the franchisor or its affiliates. The total investment necessary to begin operation of an Air franchise ranges from \$86,000 - \$176,000, which does not include the cost of leasing or purchasing real estate. This includes \$44,000 that must be paid to the franchisor or its affiliates. The estimates above do not include the cost of buying or renting real estate for your business.
