The Franchise is an odor control and commercial hygiene system, including scheduled cleaning of restrooms and servicing of deodorizing and product dispensing equipment. The general market is commercial businesses such as offices, care facilities, food stores, restaurants, etc.

The total investment necessary to begin operations of an Aire-Master franchise is from \$34,084 to \$126,900 (including the franchise fee and inventory), depending on size, location, population, and market potential. This sum does not include rent for the business location. The minimum initial fee (franchise fee plus required inventory purchase) is \$22,900, is typically \$35,500, ranges up to \$69,500, and in the fiscal year ending March 31, 2012, the initial fee was \$22,552-25,885 for all new franchises sold, but may be more or less in particular circumstances.
