The Airtime Trampoline & Game Park franchise business is a family entertainment facility that features trampolines, arcade games, and concessions and that hosts birthday parties, corporate, and charitable events. You may purchase a single franchise or an area development franchise.

The total investment necessary to begin operation of an Airtime Trampoline & Game Park single franchise is from \$1,030,500 to \$1,696,000. This includes \$40,000 that must be paid to the franchisor or its affiliates. The total investment necessary to begin operation of an Airtime Trampoline & Game Park area development franchise is from \$62,500 to \$205,000. This includes from \$60,000 to \$200,000 that will be paid to the franchisor or its affiliates.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
