The Franchise offered is for the operation of a garage door installation, repair and service business under the name "Aladdin Doors<sup>TM</sup>." The total investment necessary to begin operation of an Aladdin Doors franchise ranges from \$69,725 to \$129,775. This includes initial fees and payments of \$20,000 to \$20,200 that must be paid to the Franchisor or our affiliate. The total investment necessary for a conversion franchisee to begin operation of an Aladdin Doors franchise ranges from \$36,595 to \$79,645. This includes initial fees and payments of \$12,500 to \$12,700 that must be paid to the Franchisor or our affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read the disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or any affiliate in connection with the proposed franchise sale.
