The Franchise offered is for the operation of a garage door installation, repair and service business under the name “Aladdin Doors®”

The total investment necessary to begin operation of an Aladdin Doors franchise is \$30,300 to \$109,550. This includes \$10,000 to \$50,200 that must be paid to the Franchisor or affiliate. The total investment necessary to begin operation of an Aladdin Doors conversion franchisee is \$20,300 to \$40,000. This includes \$10,000 to \$15,200 that must be paid to the Franchisor or affiliate.
