Alice's Tea Cup is a whimsical, tea inspired restaurant and bakery operating under the name Alice's Tea Cup®. It features a variety of desserts, sandwiches, salads, soups, over 140 loose teas along with other hot and cold beverages including alcohol, wine and beer. There are two types of franchises, full service restaurants and kiosks.

The total investment necessary to begin operation of an Alice's Tea Cup restaurant franchise ranges from \$399,500 to \$795,000. This includes \$35,000 that must be paid to the Franchisor. The total investment necessary to begin operation of an Alice's Tea Cup® kiosk franchise is \$134,000 to \$276,700. This includes \$20,000 that must be paid to the Franchisor.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. **Note however, that no government agency has verified the information contained in this document.**

- 1 THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY LITIGATION ONLY IN THE STATE OF NEW YORK. OUT OF STATE LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO LITIGATE WITH US IN NEW YORK STATE THAN IN YOUR HOME STATE**

- 6 **FOR A KIOSK FRANCHISE, A FRANCHISEE'S INITIAL INVESTMENT OF \$134,000 TO \$276,700 EXCEEDS THE FRANCHISOR'S TOTAL MEMBERS' EQUITY OF \$1,730 AS OF JANUARY 31, 2018**
