This Franchise Disclosure Document describes three franchises. The All Tune and Lube® franchisee will perform general automotive repairs, excluding engine replacements/exchanges and transmission exchanges/rebuilds/clutch replacements. The ATL Motor Mate® franchisee will perform automotive engine replacements/exchanges. The All Tune Transmissions® franchisee will perform transmission exchanges/rebuilds and clutch replacements. The same franchisee may own one or more of these franchises in various combinations as described in this Franchise Disclosure Document.

The total investment necessary to begin operation of an All Tune and Lube® franchise is \$112,000 to \$146,500. This includes \$69,200 to \$99,500 that must be paid to the franchisor.

The total investment necessary to begin operation of an ATL Motor Mate® franchise is \$93,800 to \$119,000. This includes \$69,200 to \$99,500 that must be paid to the franchisor.

The total investment necessary to begin operation of an All Tune Transmissions® franchise is \$101,800 to \$132,500. This includes \$69,200 to \$99,500 that must be paid to the franchisor.

This Franchise Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
