As a franchise member, you will market a full range of printing and marketing communication services to businesses and the general public.

The total initial investment necessary to acquire an independent business and convert such business to an Allegra Center under our MatchMaker® program ranges from \$202,720 to \$589,654. This includes \$52,230 to \$57,260 that must be paid to the franchisor (which consists of a \$45,000 initial franchise fee, marketing expenditures and local website setup).

The total initial investment necessary to begin operation of a start-up Allegra Center ranges from \$167,352 to \$506,532. This includes \$46,530 to \$51,560 that must be paid to the franchisor (which consists of a \$35,000 initial franchise fee, marketing expenditures, local website setup and software).

We also offer a franchise to qualified candidates that own an independent printing and marketing communication services business to retain ownership of the business and convert the existing business to an Allegra Center through our Advantage program. The total investment necessary to convert your existing business to an Allegra Center through our Advantage program ranges from \$30,695 to \$169,404. This includes \$17,230 to \$22,260 that must be paid to the franchisor (which consists of a \$10,000 initial franchise fee, marketing expenditures and local website setup).

This Franchise Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Franchise Disclosure Document and all accompanying agreements carefully. You must receive this Franchise Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.

Buying a franchise is a complex investment. The information in this Franchise Disclosure Document can help you make up your mind. YOU MAY HAVE TO SIGN A NEW AGREEMENT WITH DIFFERENT TERMS AND CONDITIONS IN ORDER TO CONTINUE TO OPERATE YOUR BUSINESS. BEFORE YOU BUY, CONSIDER WHAT RIGHTS YOU HAVE TO RENEW YOUR FRANCHISE, IF ANY, AND WHAT TERMS YOU MIGHT HAVE TO ACCEPT IN ORDER TO RENEW.

Please consider the following RISK FACTORS before you buy this franchise:

- 1. THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY ARBITRATION OR LITIGATION ONLY IN MICHIGAN. OUT OF STATE ARBITRATION OR LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE OR LITIGATE WITH US IN MICHIGAN THAN IN YOUR HOME STATE.
- 2. THE FRANCHISE AGREEMENT STATES THAT MICHIGAN LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTION AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- 3. IF YOU ARE A BUSINESS ENTITY, YOUR OWNERS WILL HAVE TO GUARANTY YOUR OBLIGATIONS AND BE BOUND BY THE PROVISIONS OF OUR FRANCHISE AGREEMENT. THE SPOUSES OF THE OWNERS MAY ALSO BE REQUIRED TO CONSENT TO THE GUARANTY, WHICH PLACES THE SPOUSES' MARITAL ASSETS AT RISK.
  - 4. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We use the services of one or more franchise brokers or referral sources to assist us in selling our franchise. A franchise broker or referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
