As a franchise member, you will market a full range of marketing and business communication services to businesses and the general public.

The total initial investment necessary to acquire an independent business and convert such business to an Allegra Center under our MatchMaker® program ranges from \$202,254 to \$558,027. This includes \$59,400 to \$63,700 that must be paid to the franchisor (which consists of a \$45,000 initial franchise fee, an initial marketing package, website setup and software).

We also offer a franchise to qualified candidates that own an independent business to retain ownership of the business and convert the existing business to an Allegra Center through our Advantage program. The total investment necessary to convert your existing business to an Allegra Center through our Advantage program ranges from \$32,134 to \$217,452. This includes \$24,400 to \$28,700 that must be paid to the franchisor (which consists of a \$10,000 initial franchise fee, an initial marketing package, website setup and software).

This Franchise Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Franchise Disclosure Document and all accompanying agreements carefully.
