Alloy Wheel Repair Specialists, LLC. ("AWRS") offers franchises for the establishment, development, and operation of a business that provides cosmetic restoration and structural repair of automobile wheels within exclusive territories. AWRS also offers franchises for the establishment, development, and operation of a retail business and remanufacturing center that provides the sale of "after-market" chrome wheels, tires, cosmetic restoration and structural repair of automobile wheels.

The total investment necessary to begin operation of an Alloy Wheel Repair Specialists franchise is from \$157,000 to \$567,500 for mobile franchise businesses to as much as \$1,294,250 for a remanufacturing operation to begin. That includes from \$73,000 to \$324,000 which must be paid to the franchisor and its affiliate both as an initial franchise fee and for required initial equipment purchases.

This disclosure document summarizes certain provision of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
