The franchisee will establish and operate an Aloft[®] hotel (the "Aloft Hotel" or "Brand Hotel") under a franchise agreement with The Sheraton LLC.

The total investment necessary to begin operation of a 136 guest room new build Aloft Hotel franchise is approximately \$15,687,000 to \$21,923,000, which includes approximately \$170,000 to \$383,000 that must be paid to the franchisor or its affiliates. The total investment necessary to begin operation of a 136 guest room conversion Aloft Hotel franchise is approximately \$1,249,250 to \$11,248,000, which includes \$177,250 to \$393,000 that must be paid to the franchisor or its affiliates. These sums do not include any costs for real estate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

OUT OF STATE LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO LITIGATE WITH US IN NEW YORK THAN IN YOUR HOME STATE.
