The franchise described in this Disclosure Document is for the operation of a business that provides mathematic enrichment, reading and writing, English language programs and other programs to children ages 5-12.

The total investment necessary to begin operation of an ALOHA<sup>®</sup> franchise is \$37,075 to \$95,100. This includes \$16,200 to \$17,000 that must be paid to the franchisor or affiliate. The total investment necessary to begin operation of an ALOHA<sup>®</sup> Area Development franchise is \$37,075 to \$95,100 plus an Area Development fee equal to \$3,500 multiplied by the number of additional Franchises you intend to develop. This includes \$16,200 to \$17,000 plus the Area Development Fee that must be paid to the franchisor or affiliate.

This Disclosure Document summarizes certain provisions of the Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payments to us or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

IT MAY ALSO COST YOU MORE TO MEDIATE, ARBITRATE, OR LITIGATE WITH US IN NEW JERSEY THAN IN YOUR OWN STATE.
2. THE FRANCHISE AGREEMENT STATES THAT NEW JERSEY LAW GOVERNS THE AGREEMENTS, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
3. THE FRANCHISE AGREEMENT PROVIDES FOR THE IMPOSITION OF LIQUIDATED DAMAGES IF WE TERMINATE YOUR FRANCHISE AGREEMENT FOR CAUSE.
4. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
