The franchise offered is to operate an AlphaGraphics® Business Center, which offers customized print and marketing solutions to businesses using data driven, multi-channel communications that may require a blend of design, print, web, mobile and social media services.

The estimated total initial investment necessary to begin operation of a new AlphaGraphics® Business Center franchise is \$260,800 to \$394,400, excluding real estate costs. This includes \$~~63,000~~48,000 in initial fees that must be paid to the franchisor or an affiliate. The estimated total initial investment necessary to begin operation of an AlphaGraphics® Business Center franchise under our Conversion Pathway is \$57,500 to \$279,800, excluding real estate costs. This includes \$~~12,500~~10,000 in initial fees that must be paid to the franchisor or an affiliate. The estimated total initial investment necessary to begin operation of an AlphaGraphics® AGStudio ~~Sales Office~~ franchise is \$51,500 to \$~~116,500~~136,500, excluding real estate costs. This includes \$~~21,500 to \$31,500~~14,000 - \$24,000 in initial fees that must be paid to the franchisor or an affiliate.
