Three franchises are offered: A franchise is offered to establish and operate a business specializing in the sales and installation of automotive window tint, alarms and other vehicle accessories operated under the service mark "Alta Mere®;" a franchise is offered to establish and operate an Alta Mere business that also specializes in flat glass window film and treatment services under the service mark "SmartView®;" and a franchise is offered to establish and operate an Alta Mere business that also offers automotive tune-ups, vehicle maintenance, brakes and air conditioning service and repair under the service mark "Milex Complete Auto Care®." Franchises can be established in two ways: as a start-up business or by conversion of an independent business specializing in the sales and installation of automotive window tint, alarms and other accessories to a franchised business. We offer Area Representative franchises under a separate Franchise Disclosure Document.

The total investment necessary to begin operation of an "Alta Mere" store ranges from \$114,619 to \$169,847. This amount includes \$38,000 that must be paid to the franchisor or affiliate. The total investment necessary to begin operation of an Alta Mere/SmartView Co-Branded franchise ranges from \$140,159 to \$196,037. This amount includes \$43,000 that must be paid to the franchisor or affiliate. The total investment necessary to begin operation of an Alta Mere/Milex Co-Branded franchise ranges from \$195,794 to \$283,941. This amount includes \$47,830 that must be paid to the franchisor or affiliate. The franchise fee is discounted for area developers. The total investment necessary to become an area developer ranges from \$136,619 to \$361,847. This amount includes an area developer fee of \$10,000 for each franchised business to be developed, \$20,000 franchise fee for the first Store and \$8,000 that must be paid to the franchisor or affiliate. The total investment necessary to become an Alta Mere/SmartView Co-Branded area developer ranges from \$162,159 to \$388,037. This includes \$10,000 for each franchised business to be developed, a \$25,000 franchise fee for the first Co-Branded Store and \$8,000 that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign



a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.
