The franchisee will operate a business that offers and sells leadership-based dog training and behavior modification support services using the primary name and mark “Always Faithful Dog Training.”

The total investment necessary to begin operation of an Always Faithful Dog Training franchise business is \$42,500 to \$65,500. This includes \$40,000 paid to the franchisor (unless you are eligible for a reduced fee).

OUT OF STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST MORE TO ARBITRATE WITH ALWAYS FAITHFUL DOG TRAINING, INC. IN ILLINOIS THAN IN YOUR HOME STATE.
2. THE FRANCHISE AGREEMENT STATES THAT ILLINOIS LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
3. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
