As a franchisee, you will operate an Amada senior care business that provides and markets non-medical homemaker, companionship, personal care services, personal technology services, and equipment to the elderly and others who need assistance in daily living, as well as placement services for seniors.

The total investment necessary to begin operation of an Amada senior care franchise is \$92,210 to \$169,154.171,654. This includes \$45,000 that must be paid to the franchisor or its affiliates. If you are an existing Amada franchisee, we may offer you the right to develop and operate additional Amada senior care franchises. The total investment necessary for your second and any subsequent Amada senior care franchise will vary based on the reduced Initial Franchise Fee we charge you for each franchise, our then-current Initial Franchise Fee at the time you commit to develop the franchise(s), and the number of franchises you commit to develop.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least fourteen (14) calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale.
