The franchise described in this disclosure document is for a retail salon business utilizing the "Amazing Lash Studio" concept and our business operating system to provide luxury semi-permanent and temporary eyelash services, eyebrow services, hair removal, facial and body treatments, and related products and services.

The total investment necessary to begin operation of an Amazing Lash Studio franchise ranges from \$223,692 to \$537,542. This includes \$64,000 to \$98,000 that must be paid to us or our affiliates for your initial franchise fee and initial inventory/supplies and furniture. (See Item 5)

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

AS OF DECEMBER 31, 2017, THE FRANCHISOR HAD A NEGATIVE NET WORTH OF (\$10,165,191) AND NEGATIVE WORKING CAPITAL IN THE AMOUNT OF (\$4,339,057). A PROSPECTIVE FRANCHISEE SHOULD REFER TO THE FINANCIAL STATEMENTS FOR COMPLETE DETAILS.
- 5. YOU MUST PERSONALLY GUARANTEE THE FRANCHISEE'S OBLIGATIONS UNDER THE FRANCHISE AGREEMENT. YOUR SPOUSE MUST ALSO SIGN A PERSONAL GUARANTEE, MAKING YOUR SPOUSE INDIVIDUALLY LIABLE FOR YOUR FINANCIAL OBLIGATIONS UNDER THE AGREEMENT. THE GUARANTEE WILL PLACE YOUR SPOUSE'S MARITAL AND PERSONAL ASSETS AT RISK IF YOUR FRANCHISE FAILS.
- 6. YOU MUST COMPLY WITH MINIMUM AND/OR MAXIMUM PRICES SET BY THE FRANCHISOR FOR THE GOODS AND SERVICES YOU SELL. THIS REQUIREMENT MAY REDUCE YOUR ANTICIPATED REVENUE AND NET INCOME.
