The franchised business you will own and operate is an affordable fitness center that sells 1, 2 or 3-year contract terms and non-contract memberships are available with dues payable monthly or cash memberships paid in advance either under the names "American Bodyworks" depending on the size of the center ("Outlet").

The Initial Franchise Fee varies from \$14,999 for the right to open a single Outlet, \$24,999 for the right to open 4 Outlets and \$34,999 for the right to open up to 8 Outlets (see **ITEM 5**). The estimated initial investment required for an American Bodyworks ranges from \$71,149 to \$245,999 based on equipment lease package and \$134,149 to \$415,499 based on equipment purchase. (See ITEM 7).

American Bodyworks: American Bodyworks is the premier 24/7 neighborhood club. A neighborhood club a fitness center that is anywhere from 3,000 to 8,000 square feet and can be found in any strip mall in any neighborhood! The best part is that members can use these clubs at anytime they want because they are key access clubs. A Key club is a fitness center where each member has a key card giving them access to the club 24 hours a day ... 7 days a week! Our facilities have a great modern look. Mirrors surround the walls with diamond plate metal beneath them. Strips of blue and red neon line the upper portion of the wall accenting your walls. LCD screen televisions are strategically placed throughout the facility allowing your customers to be entertained in between sets. From your front desk, you can keep an eye on your whole club. We hold a standard that all franchisees must keep their clubs spotless. Shower closets help members feel comfortable at all hours. American Bodyworks is made for the member.

Regional Developers

Under this program, you will sign a Regional Development Agreement under which we will assign you a defined territory within which you must solicit, recruit, screen and interview prospective franchisees for us, help our franchisees identify and secure sites for American Bodyworks Centers in that territory and provide operational, training and field support to American Bodyworks franchisees whose Centers are located within that territory, both before and after they open their American Bodyworks Centers. The total investment necessary for a Regional Franchise ranges from \$183,250 to \$436,680, which includes a regional franchise fee ranging from \$162,000 to \$360,888, or more, depending upon the population in your territory, which must be paid to the Franchisor. These sums do not represent your total investment in the American Bodyworks regional franchise. You should refer to Items 5 through 7 of this Disclosure Document for further information regarding your investment.
