Franchisees will own and operate hotels offering distinctive, high quality lodging services to the general public under the name "American Idea<sup>TM</sup> Hotels." We estimate that the total investment necessary to construct and begin operation of a typical American Idea<sup>TM</sup> Hotel will range from \$5,805,250 to \$10,012,500, which includes \$44,500 that must be paid to us. The above estimate excludes the purchase price of the real estate and site preparation expenses.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
