The total investment necessary to begin operations of an American Lenders Service Company franchise ranges from \$15,694 to \$112,494 (See Item 7 of this Disclosure Document.) This includes the initial set-up fee of \$2,986.00 and the cost of the franchise, which ranges from \$200.00 to \$20,000.00, that must be paid to us. (See Item 5 of this Disclosure Document.) These numbers are based upon the assumption that you bring NO equipment into your start-up, and that you receive no credit or reduction from ALSCO on the required start-up fees.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale.
