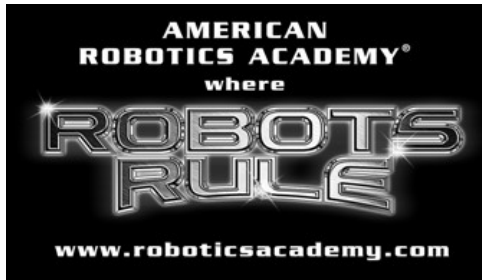

The franchisee will operate a business (an “**American Robotics Academy Business**”) that specializes in educational-based, productive, curriculum-based teaching of various levels of robotics in order to provide students with an educational and recreational experience that is fun, educational, and functional.

The total initial investment necessary to begin operation of an American Robotics Academy Business ranges from \$31,820 to \$69,220. This includes \$15,000 to \$25,000 that must be paid to us or our affiliates.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

Buying a franchise is a complex investment. The information in this disclosure document can help you make up your mind. - 1* THE FRANCHISE AGREEMENT PERMITS THE FRANCHISEE TO LITIGATE AND MEDIATE ONLY IN TEXAS. OUT OF STATE LITIGATION OR MEDIATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST MORE TO LITIGATE OR MEDIATE WITH THE FRANCHISOR IN TEXAS THAN IN YOUR HOME STATE.
