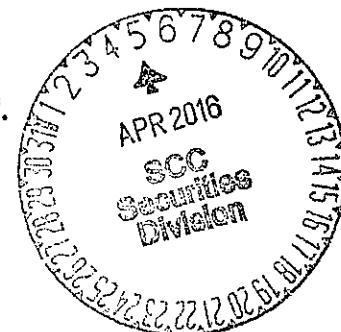

The Franchise offered is for a business which provides thermographed (raised-letter) printing and other printing/reproduction related services at the wholesale level under the name American Wholesale Thermographers and AWT.

The total investment necessary to begin operation of an American Wholesale Thermographers franchise is estimated between \$406,350.00 and \$514,850.00. This includes \$70,350.00 that must be paid to the franchisor.

This Franchise Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Franchise Disclosure Document and all accompanying agreements carefully. You must receive this Franchise Disclosure Document at least fourteen (14) calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
