You will operate a restaurant that celebrates the American hot dog experience by featuring city-themed hot dogs as well as hamburgers, sausages, sandwiches, salads, wraps, soft drinks, and related items for dine-in, carry-out, and drop-off catering under the name AMERICA'S DOG AND BURGER.

The total investment necessary to begin operation of an AMERICA'S DOG AND BURGER franchised business ranges from \$298,800 to \$694,050. This includes \$30,000 that must be paid to the franchisor or its affiliate(s). If you are acquiring development rights under a development program, you will sign our development agreement and pay us a development fee equal to \$30,000 for the first franchise and \$10,000 for each additional franchise you commit to develop.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.
