The franchisee will operate a business that operates a center offering entertainment and team building experience attractions through fully immersive and challenging escape room scenarios based on innovative game theory.

The total investment necessary to begin operation of an America's Escape Game franchise is from \$541,000 to \$1,084,800 (not including real property), including \$186,000 to \$268,000 that must be paid to the franchisor or its affiliate. The total investment necessary to begin operation of an America's Escape Game Area Development franchise is from \$37,000 to \$99,000 (assuming, for the low end of the range 2 America's Escape Game Centers and for the high end of the range 6 America's Escape Game Centers, although this is not a maximum), including \$30,000 to \$90,000 that must be paid to the franchisor or its affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.

OUT OF STATE LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES.
