The franchise offered is for the operation of a residential and commercial inspection business.

The total investment necessary to begin operation of an AmeriSpec franchise ranges from: \$50,900 or \$51,350 to \$72,400 or \$41,350 to \$62,400 depending on the territory. This includes \$39,400 or \$29,400 that must be paid to the franchisor.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement or make any payment in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

1. THE FRANCHISE AGREEMENT PERMITS THE FRANCHISEE TO ARBITRATE WITH AMERISPEC, INC. ONLY IN TENNESSEE. OUT-OF-STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT. IT MAY ALSO COST YOU MORE TO ARBITRATE WITH US IN TENNESSEE THAN IN YOUR HOME STATE.

2. WE MAY TERMINATE YOUR FRANCHISE AGREEMENT IF YOU DO NOT REACH CERTAIN REVENUES AND MARKET SHARE IN YOUR BUSINESS IF YOUR AGREEMENT WITH US HAS GROWTH REQUIREMENTS.

THE FRANCHISE AGREEMENT STATES THAT THE LAW OF TENNESSEE GOVERNS THE AGREEMENT. THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.

3. ALTHOUGH THE FRANCHISE AGREEMENT PROVIDES THAT TENNESSEE LAW APPLIES, LOCAL LAW MAY SUPERSEDE IT IN YOUR STATE. PLEASE REFER TO ANY STATE-SPECIFIC ADDENDUM THAT MAY BE ATTACHED TO THE DISCLOSURE DOCUMENT.

4. PLEASE NOTE THAT 81.6% OF THE SERVICEMASTER COMPANY ASSETS ARE INTANGIBLE. YOU MAY WANT TO CONSIDER THIS WHEN MAKING A DECISION TO PURCHASE THIS FRANCHISE OPPORTUNITY.

5. YOU MUST PAY US MINIMUM SERVICE FEES OF \$250 EACH MONTH AND MINIMUM ADVERTISING FEES OF \$125 EACH MONTH, EVEN IF YOUR FRANCHISE BUSINESS HAS NO REVENUE.

6. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
