The total investment necessary to begin operation of an AmeriSpec franchise ranges from: \$53,150 to \$75,800 or \$43,150 to \$65,800 depending on the territory. This includes \$41,200 or \$31,200 that must be paid to the franchisor.

2. WE MAY TERMINATE YOUR FRANCHISE AGREEMENT IF YOU DO NOT REACH CERTAIN REVENUES AND MARKET SHARE IN YOUR BUSINESS IF YOUR AGREEMENT WITH US HAS GROWTH REQUIREMENTS.
3. THE FRANCHISE AGREEMENT STATES THAT THE LAW OF TENNESSEE GOVERNS THE AGREEMENT. THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.

6. YOU MUST PAY US MINIMUM SERVICE FEES OF \$250 EACH MONTH AND MINIMUM ADVERTISING FEES OF \$125 EACH MONTH, EVEN IF YOUR FRANCHISE BUSINESS HAS NO REVENUE.
7. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
